to me in hand paid at and before the sealing of these  
presents by Zephania Hightower of Greenville County South  
Carolina, (the receipt whereof is here by acknowledged)  
have granted, bargained, sold and released, and by  
these presents do grant, bargain, sell and release unto  
the said Zephania Hightower, a tract, piece or parcel  
of land lying and being situated in the County of  
Greenville in the state aforesaid on the head of a  
small branch, Waters of North Fork of Saluda River  
and is the land on the North and North East side of  
the New Ridge road, of the tract of land conveyed to me  
by B. C. Hawkins, known as part of the John Hawkins  
tract of land, and contains Thirty one acres and One  
fourth acres (31 1/4) more or less and runs as follows
