

we, M P Landrum and Rosa B McRee of the city and county of Greenville

in the State aforesaid, in consideration of the sum of Two Thousand two hundred  
Dollars, to us in hand paid at and before the sealing

of these Presents, by Lula M Briggs  
(the receipt whereof is hereby acknowledged,) have granted, bargained, sold and released, and by these Presents, DO  
GRANT, bargain, sell and release unto the said Lula M Briggs all our right title and interest

this same being a one undivided two thirds interest of in or to all and singular that piece parcel  
and tract of land situate lying and being partly in Greenville County and partly in Spartanburg  
county in the State aforesaid on both sides of Middle Tiger River and Gold Mine Branch of said River  
the same being a part of the real estate of Hardy McRee deceased and designated as Tract A in a plat  
of the lands of said estate recorded in book page 38 by reference thereto a more full description may  
be had also our undivided two thirds interest of in or to all and singular that other tract in Greenville  
County on waters of Middle Tiger River being tract B of the estate of said Hardy McRee deceased  
fully described in the plat as above referred to and recorded in Register of Deeds conveyance office of Greenville  
county also our undivided two thirds interest of in or to all and singular that tract in the County  
and State aforesaid on the N.W. side of the Jordan Road and on waters of Middle Tiger River and branch  
in the other mentioned tract as tract C of the estate lands of Hardy McRee dec. The above described
