of land situate lying and being in the City of Greenville County of Greenville State aforesaid fronting on Towne Street in City and containing thirty one hundredths of an acre more or less, and having the following lines and bounds to wit: Beginning at a stake on Towne Street running south 70° 3' east 120 ft to a stake in an alley, thence with said alley, south 18° 45' west 47 ft to another stake in said alley, thence north 72° 3' west 12 ft to a stake on Towne street thence with said street 47 ft to the beginning corner bring the lot as lot #4 on a roll made for me by C. W. Whitmore. In further and bring the same lot correspondingly from the office of Greenville County Register page 233 and lot number also bounded on North by lot #1 of land formerly occupied by J. W.
