in the State aforesaid, in consideration of the sum of *Twelve hundred and 600 dollars*, at present £ 120, and in five years annual *Dollars*, to my hand paid at and before the sealing of these Presents by *Joseph Allevine* in State aforesaid Greenville County (the receipt whereof is hereby acknowledged,) have granted, bargained, sold and released, and by these Presents, DO GRANT, bargain, sell and release unto the said *Joseph Allevine*, *200* feet price per acre or lot of land situate in the County & State aforesaid on the branch waters of *Emmick's river*, beginning at a stone, thence *87 1/2* E. 20 ft. to a stake thence *8 1/2* N. *87 1/2* E. 30 ft. to another to a ash down, on a branch thence down with the boundaries of said branch to a Spanish oak thence to a stone about 20 ft. thence *82 3/4* N. *24 1/2* E. 105 ft. to the joining corner containing *Eng. three and three fourths acres* to the square more or less. Bounded by lands of *E. Marsden*, *John Garret*, *S. Price* and others.

TOGETHER with all and singular the Rights, Members, Hereditaments and Appurtenances to the said Premises belonging or in anywise incident or appertaining.
