Twenty five Dollars, to me in hand paid at and before the sealing
of these Presents, by Greenville Page
(the receipt whereof is hereby acknowledged,) have granted, bargained, sold and released, and by these Presents, DO
GRANT, bargain, sell and release unto the said Greenville Page

See that piece, parcel and tract of Land, seven acres, more or less,
situate, lying and being in Greenville County in the State aforesaid, near the Eastern
limits of the city of Greenville, the same being a part of a forty acre tract, bought by Basil
Mawley at the sale of the Estate lands of Mrs. Dorcas Brown, deceased. By division of said tract,
amounting ten acres and four and three quarters acres, and represented by "B" and "D" in a
plan made by McRae & S., was sold to me by said master by deed of date 25th day of May
1888 and recorded in R. M. C. Office for Greenville County Vol. "A. S." page 330. The tract
I hereby convey to the said Page being Division "D" containing four and three fourths
acres, and two and seven acres by division "B" adjoining the same. Bounded by lands of
Jacob Miller, Warren Peasey, Jim Hall, Millet Parker and others.
