WHEREAS A B Beane and others

on or about the 14th day of September in the year of our Lord eighteen hundred and Ninety two exhibited this complaint in the Court of Common Pleas, for the County aforesaid, against

demanding judgment in relation to the real estate hereinafter mentioned and described; and the cause being at issue, came on to be heard on the 26th day of November 1892, and such proceedings were had therein as resulted in a decree of the said Court, whereby it was adjudged and decreed that the said real estate hereinafter mentioned and described, be sold by D P Verner Master, in and for the County aforesaid, on the terms and for the purposes mentioned in the said decree as by reference thereto on file in said Court, will appear; and the said Master, after having duly advertised the said real estate for sale by public outcry, on the 1st and day of January in the year of Lord, eighteen hundred and Ninety three did then openly and publicly, and according to the custom of auction, sell and dispose of the same unto

for the sum of three hundred and forty five Dollars, being at that price the highest bidder therefor, NOW THEREFORE, Know all Men by these Presents, that I,

D P Verner Master, in and for the County of Greenville aforesaid, in consideration of the sum three hundred and forty five Dollars to me paid by the said

B F McKinzie

the receipt whereof is hereby acknowledged, HAVE GRANTED, bargained, sold, and released, and by these presents DO GRANT, bargain, sell, and release unto the said

B F McKinzie all that tract of land situated in the County and State of South Carolina, near the town of Piedmont on the west side of the road leading from Greenville to Piedmont containing eleven & $\frac{1}{2}$ acres more or less, known in the division and sale of the real estate of Ruben Beane deceased as lot No 3, having the following lines and bounds, Beginning at a stake on the west side of said road, and running eastward along said road towards Greenville 7.25 to a stake, thence N 87° E 19.00 to a stake on the bank of Saluda River thence down the river to a stake, thence S 84° E 19.50 to the beginning. See plat in the record of said case No Roll 0509.

Also lot No 2 beginning on McKinzie's corner, thence S 87° E 85.00 to a stone on Egg Rd, thence along said road to a stake S 87° E 85.00 to a stake on the Piedmont Road, thence along said road 5.00 to the beginning containing nine acres, more or less,
