the receipt whereof is hereby acknowledged, HAVE GRANTED, bargained, sold, and released, and by these presents DO GRANT, bargain, sell, and release unto the said

Lewis W. Parker and Frank Hammond, All that tract of land situate in the County and State aforesaid, in legal township, on head water of Chaudler's Branch, adjoining lands of Pleasant Mader, estate of Henry Ashwood, Sam Owens, R. H. Jacobs, Dr. Wiley Jones and others, containing one hundred and fifty acres, more or less, being the same tract conveyed to P. Meehan and others by Sanford Meehan on the -- -- day of May, 1856.

TOGETHER with all and singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining; and all the estate, right, title, claim, and interest whatsoever, of the parties to the cause aforesaid, and of each of them, in and to the same; and of all other persons rightfully claiming from, under, or by these or any of them.
