by lands of *D W Hinstey* *Alex Abernethy*, and others
and containing *one hundred and forty nine and one half*
acres, being the tract of which *Richard Edlow* died
seized, and possessed and on which he lived up to the
time of his death,

TOGETHER with all and singular the Rights, Members, Hereditaments and Appurtenances to the said premises
