Now therefore know all men by these presents that we William G. McDavid and Robert H. McDavid who with the said J Lee McDavid are the only heirs at law of said A.R. McDavid, for and consideration of the premises and the further consideration of Five Dollars to us in hand paid by J Lee McDavid, the receipt whereof is hereby acknowledged, have granted bargained sold and released, and by these presents do grant, bargain, sell and release unto the said J Lee McDavid, all our right, title, interest or estate of in or to the following described lots of land, situate lying and being in the City and County of Greenville and State aforesaid, to wit:

All that certain piece parcel or lot of land situate lying and being on the south East Corner of Washington and Richardson Streets in the City of Greenville, County and State aforesaid and bounded as follows: Beginning at an iron pin on south East Corner of Washington and Richardson Streets, and run thence S 20 W 90 feet with Richardson Street to an iron pin, thence S 70 E 50 feet to an iron pin, thence N 20 E 90 feet to an iron pin on Washington Street, thence N 70 W 60 feet with Washington Street to the beginning corner.

Also that other piece parcel or lot of land in the same City County and State, beginning on an iron pin on Richardson Street, one hundred and fifty feet from Washington Street, and run thence with Richardson Street S 20 W 30 feet to an iron pin, thence S 70 E 100 feet to an iron pin on Gowers line thence with Gowers line N 20 E 80 feet to an iron pin, thence N 70 W 100 feet to the beginning corner, both of the said lots being a part of A.R. McDavid's

Together with all and singular the rights members hereditaments and appurtenances, to the said premises belonging or in any wise incident or appertaining. To have and to hold, all and singular the said premises before mentioned unto the said J Lee McDavid his heirs and assigns forever.


