Ida Charles the receipt whereof is hereby acknowledged, Have granted, bargained, sold and released, and by these presents do Grant, bargain, sell and release unto the said E. Ida Charles, the following real estate:

1. All that certain tract of land lying in Gannt Township State and County aforesaid, adjoining lands of J. F. West, J. M. D. Ashmore and others. Beginning at a rock corner on the line between lands formerly belonging to James H.
