KNOW ALL MEN BY THESE PRESENTS, That we, Eli Franklin McMahan, George A. McMahan, and Wm. G. McMahan, of Grayson County Texas, and Frances L. Francis (formerly McMahan) of the same place, and Lucinda E. Saunders, (formerly McMahan) of Tishomingo, in the Indian Territory, for and in consideration of the sum of Eight hundred and Ninety one Dollars, to us in hand paid at and before the sealing of these presents by Wm. Estley McKinney, of Greenville, South Carolina, (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Wm. Estley McKinney, all that piece, parcel and tract of land situate in Highland Township, in Greenville County, in the State of South Carolina, fronting on the Tugalo Road, and about 18 miles from Greenville Court House, and adjoining lands of B.P. Neves, Isabel Bailey, M. Luther McKinney, and others and is a part of the tract once owned by Jane Taylor, (who afterwards intermarried with one McMahan). Said tract contains ninety nine (99) acres, more or less, and hath such shape, metes and bounds courses and distances as represented by a Plat of same made by Will D. Neves, dated Dec. 24, 1902 hereto attached and made a part of this conveyance. The aforesaid land is a part of the tract that was conveyed to Said Jane Taylor (afterwards McMahan) by her Trustee, Wm. McKinney, duly appointed such by the will of Jas. McKinney, under proceedings filed in the Probate Court for Greenville County S.C. in the cause entitled Wm. McKinney Trustee vs Jane Taylor, and by reference to the said will of Jas. McKinney duly probated in the office aforesaid and recorded in book D. at pages 264, 265 and 266, on the 6th day of Sept. 1861. We, the said Grantors, are the only children of said Jane McMahan, who died some 19 years ago, and as will fully appear by reference to said Will the land become our absolute property.

TOGETHER with all and singular the Rights, Members, Hereditaments and Appurtenances to the said Premises belonging, or in anywise incident or appertaining. TO HAVE AND TO HOLD, all and singular the said premises before mentioned unto the said Wm. E. McKinney, and to his Heirs and Assigns forever.

Estley McKinney, and to his Heirs and Assigns, against us and our Heirs and all persons whomsoever lawfully claiming or to claim the same or any part thereof.
