THE STATE OF SOUTH CAROLINA.

BY THE SECRETARY OF STATE.

WHEREAS, H. J. Haynsworth, Thomas F. Parker F. W. Poe, G. A. Norwood and T. Q. Donaldson, a majority of the Board of Directors of Monaghan Mills a corporation created under and pursuant to the laws of South Carolina, by certificate issued under the hand of the Secretary of State, and the Great seal of South Carolina, on the 16th day of April A.D. 1900,

HAVE CERTIFIED over their signatures; Resolutions authorizing in behalf of the aforesaid Corporation an increase of the Capital Stock (authorized and set forth in the certificate aforesaid) to the sum of Seven Hundred Thousand Dollars, which Resolutions were adopted pursuant to law, at a meeting of the stockholders of the aforesaid corporation, of which thirty days published notice was given, which notice stated the purpose of the aforesaid meeting; and further, that said resolutions were adopted by a two-thirds vote, and that in all respect there has been complied with the provisions of "An Act to Provide for the Increase and Decrease of the Capital Stock of Corporations in this State, Except Railroad, Railway, Tramway, Turnpike and Canal Corporations". approved March 1st. A.D. 1899;

Now, Therefore, I, M.R. Cooper, Secretary of State, by virtue of the authority in me vested by an Act of the General Assembly of the State of South Carolina, entitled, "An Act to Provide for the Increase and Decrease of the Capital Stock of Corporations in this State, Except Railroad, Railway, Tramway, Turnpike and Canal Corporations", approved March 1st, A.D. 1899, and all other Acts or parts of Acts me thereto enabling, have this day endorsed across the face of the aforesaid certificate of incorporation or original charter, authority of increase as aforesaid, and I hereby Certif, that the requirements of law for said increase will have been complied with when this certificate and the endorsement across the face of the original charter aforesaid is lodged for record in the office of the Register of Mesne Conveyance or Clerk of Court in each County in which the said Corporation shall have a business office.
