Whereas his Honor Judge R. J. Purdy did on the tenth day of February A.D. 1903 sign a decree in the case of Thomas J. Wood and others plaintiffs against myself and Henry F. Payne defendants ordering and adjudging that I execute and deliver to said Henry F. Payne a good and sufficient fee-simple deed to the tract of land hereinafter described upon said Henry F. Payne paying to D. P. Verner Esq. Master for the County of Greenville in said state the sum of six hundred and sixty dollars.

KNOW ALL MEN BY THESE PRESENTS, That I, Bud C. Matthews of the County of Newberry in the State aforesaid for and in consideration of the sum of five Dollars, to me in hand paid at and before the sealing of these presents by said Henry F. Payne and also of said sum of six hundred and sixty dollars paid by the said Henry F. Payne to said D. P. Verner Esq. Master and also in consideration of said Decree made in said case as aforesaid (the receipt whereof is hereby acknowledged) have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Henry F. Payne all that piece, parcel and tract of land situate, lying and being in the County of Greenville and State aforesaid containing fifty-one and one-third acres more or less and bounded by lands of Ben Vaughan, George Eyrd, Bob. Gray, Margaret Wright and Bob. Miller and a public highway known as the Chick Springs Road and known as the Wood tract, and being the same tract of land which I bound myself to convey to Rosa A. Wood deceased by bond bearing date the 17th day of January A.D. 1901 upon her paying to me the sum of seven hundred and six and 84/100 dollars therefor at the times specified in said bond, the said bond being signed by both myself and the said Rosa A. Wood.

TOGETHER with all and singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining. TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the said Henry F. Payne his Heirs and Assigns forever.

And I do hereby bind myself, my Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the said Henry F. Payne his Heirs and Assigns, against myself and my Heirs, and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
