In the State aforesaid in consideration of the sum of Ten dollars and conditions here after named, Dollars to in hand paid at and before the sealing of these presents by A. J. Williams, W. H. Smith & T. A. Williams, Trustees, (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said A. J. Williams, W. H. Smith and T. A. Williams as Trustees of Public Schools for Greenville County in District No. 1. H. in Dunklin Township, and their successors in office, A lot of land containing one acre, be the same more or less, described as follows:-

Beginning on the Pelzer Road from the T. A. Williams Place, on a stake 3x in road, thence N. 78-3/4 E. 3-16 chains to a stake 3x, thence S. 11-1/4 E. 3-16 chains to a stake 3x, thence S. 78-3/4 W. 3-16 chains to a stake 3x, on Pelzer Road, thence N. 11-1/4 W. 3-16 chains to the beginning corner, bounded by lands of Martha Dawkins and H. B. Williams.

Now the conditions of this deed are that the said A. J. Williams, W. H. Smith and T. A. Williams, Trustees or their successors in office, are to build a comfortable frame building on said land for school purposes, also to dig a well; said house is to be kept in good condition for the term of twenty years, and at the end of that time the land with the improvements thereon shall return to Martha Dawkins, or her heirs. Also that the said Trustees or their successors in office shall not clean off all the timber on said land, but shall leave enough timber on it to make a nice grove.
