Jones, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presence do grant, bargain, sell and release unto the said W.R. Jones, (that certain lot or piece of Land, situated on the South side of Washington Street and adjoining lands of Mrs. Selma Robinson on the West, in the City of Greenville and County aforesaid, being known as Lot #5, on plat of Land of W.T. Shumate and purchased by him from James Brown, and having the following meets and Bounds.
