 stone; thence S 9° E 6° 38' to a stake; thence S 36° 1/2' E 1° 0' 00'
 to a stake; thence N. 4 E 20° 70' to the Beginning, containing
 7 1/10 acres, more or less. Bounded by lands of my self
 the said Wm. Dridwell and others.
