(the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Sidney Madney Curry, all that certain lot or piece of land lying and being in said State, Greenville County, Highland Township, on the Rutherford road adjoining lands of P.M. Waldrop, Robert Coleman and others, and being known as lot Number three of the said Robert Curry estate, having the following notes and bounds, Viz ; beginning on a stone in the middle of the said Rutherford road running; thence S. 48-1/4 E. 23.00 chs. to a stone 3 X m; thence N. 36-3/4 E. 6.60 chs. to a stone 3 X m; thence N. 48-1/4 W. 22.10 chs. to a stone 3 X m in the middle of the said Rutherford road; thence along said road 6.59 chs. to the beginning corner, containing fourteen and thirty-seven one hundredths acres, more, or less.

TOGETHER with all and singular the Rights, Members, Hereditaments and Appurtenances to the said Premises belonging, or in anywise incident or appertaining. TO HAVE AND TO HOLD, all and singular the said premises before mentioned, unto the said Sidney Madney Curry, his Heirs and Assigns forever.

And I do hereby bind Robert Currys Heirs, Executors and Administrators to warrant and forever defend all and singular, the said premises unto the said Sidney Madney Curry, his

Heirs and Assigns, against Robert Curry and his Heirs, and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
