to me in hand paid at and before the sealing of these presents by W.A. Barton of the County of Greenville, (the receipt whereof is hereby

acknowledged), have Granted, Bargained, Sold and Released and by these presents do Grant, Bargain, Sell and Release unto the said W.A. Barton, all that piece, parcel or tract of land, situate, lying and being in the State and County aforesaid on the head waters of South Tyger River and on the West side of a road leaving the State road near D.H. Noe's and going with the old Columbia Road near R.P. Giltman's, Beginning at a stake in said road and running; thence S. 70 W. 22.00 ch to a stone on John Ballengersline thence N. 21 W. 43.90 ch. to a large white-oak (corner of W.J. Bartons); thence S. 63 E. 30.36 ch. to a stone; thence N. 70 E. 8.32 ch to the said road; thence along said road in a Southerly direction to the beginning corner, containing eighty-three acres, more or less, adjoining lands of my-self W.J. and J.H. Barton and others.

TOGETHER with all and singular the rights, members, hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining.

TO HAVE AND TO HOLD, all and singular the said premises before mentioned unto the said W.A. Barton, his heirs and assigns, forever.

AND I do hereby bind myself and my heirs, executors and administrators, to warrant and forever defend all and singular the said premises unto the said W.A. Barton, and his

heirs and assigns, against me and my heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
