(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released and by these presents do Grant, Bargain, Sell and Release unto the said W.E. Hinton, his heirs and assigns, All that certain lot or parcel of land, situate just outside of the Corporate limits of the City of Greenville, County and State aforesaid known as lot number 15 in plat of survey of land of W.M. Norwood made by J.N. Southern and known as Norwood Heights, and bearing date of October 9th, 1906 and recorded in office of R.M.C. of Greenville County in Plat Book A. on page 133 said lot begins at a stake on West side of Vance Street at W.H. Lancaster's corner; thence along said Street (55ft.) fifty-five feet to iron pin on corner of Vance and Main Streets; thence along line of Main Street West (150ft.) One hundred and fifty feet to iron pin at line of Woodside Mill Land; thence North with line of Woodside Mill Land (55 ft.) fifty-five feet to iron pin; thence East along line of W.H. Lancaster (150ft.) One hundred and fifty feet to a stake on Vance Street the beginning corner.
