bargained, sold and released, and by these presents does grant, bargain, sell and release  
unto the said CHARTER PROPERTIES PROJECT PARTNERSHIP #3, its successors and  
assigns, forever;

PARCEL #1

All that certain piece, parcel or lot of land located in Greenville County,  
South Carolina, lying and being on the northwestern side of Bolton Road and  
being shown as a 20 acre tract according to a plat entitled "Survey for  
Charter Properties, Inc." by Freeland and Associates dated October 18, 1984,  
and having, according to said plat the following metes and bounds, to-wit:

BEGUNING at a point in the center of East Laurel Creek, said point being  
located approximately 758 feet, more or less, from Baywood Road and running  
thence with the center of East Laurel Creek as a line the following courses

W. 78.13 feet; N. 21°33' W. 94.51 feet; thence leaving the center of Laurel  
Creek and running with the line of property now or formerly of Goldsmith  
and Thomas S. 03°53' E. 977.69 feet to an iron pin in the line of property  
now or formerly of Charter Properties, Inc.; thence with the line of Charter  
Properties, Inc. S. 19°45' W. 132 feet to an iron pin on the northwestern  
edge of Bolton Road; thence with the northwestern edge of Bolton Road as  
the line the following courses and distances: S. 03°53' W. 171.46 feet; S.
