KNOW ALL MEN BY THESE PRESENTS, that THREATT ENTERPRISES, INC. a Corporation chartered under the laws of the State of South Carolina and having a principal place of business at Greenville, State of South Carolina, for and on behalf of itself and its successors, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto ELIZABETH B. BUCHANAN

All that lot of land situate on the southerly side of Lowndes Hill Road in the County of Greenville, State of South Carolina, being shown as a lot containing 13.54 square feet on a plat of the property of T. C. Threatt, Inc. dated December 22, 1953, prepared by Freeland and Associates recorded in Plat Book 10-6 at page 27 in the R.M.C. Office for Greenville County, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southerly side of Lowndes Hill Road, which iron pin is 157 feet, more or less, from Pointe Circle, and running thence S. 31-03 E. 167.27 feet to an iron pin; thence S. 57-55 W. 73.93 feet to an iron pin; thence N. 28-30 W. 44.25 feet to an iron pin; thence S. 53-10 W. 14.36 feet to an iron pin; thence N. 28-15 W. 125.06 feet to an iron pin on Lowndes Hill Road; thence with said road N. 09-02 E. 80.20 feet to the point of beginning.

This is a portion of the property conveyed to the grantor by deed of William D. Gilmore, Jr. recorded October 10, 1978, in Deed Book 1089 at page 631 in the R.M.C. Office for Greenville County.

This conveyance is subject to any and all existing easements, rights of way, zoning ordinances and restrictions or protective covenants that may appear of record or on the premises.

TOGETHER with nonexclusive easement 20 feet in width extending from the rear portion of the above described property, and terminating on Pointe Circle as shown on plat prepared by Freeland and Associates recorded in Plat Book 10-6 at page 27 in the R.M.C. Office for Greenville County. It is understood that this is an easement appurtenant running with the land. It is further understood that in the event the grantor herein, its successors or assigns, should determine it necessary to make a minor relocation of the subject easement that the grantee herein, her heirs and assigns, will not unreasonably withhold
