WHEREAS, I, John McCreel, the said John McCreel

in the full and just sum of Eight hundred & 800.00  
Dollars, to be paid in full by the 20 day of December 1918

with interest thereon from maturity at the rate of 8 per cent. per annum to be  
computed and paid annually

until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or  
interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may  
sue thereon and foreclose this mortgage, said note further providing for an attorney's fee of 10 per cent

besides all costs and expenses of collection, to be added to  
the amount due on said note, to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part  
thereof, be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note, reference  
being thereunto had, as will more fully appear.

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant,  
bargain, sell and release unto the said Martha Lister all that certain

piece of land in County and State aforesaid  
and lying on South side of Tugaloo road,  
beginning on a stone in the field and running  
thence S. 9 E. 16.70 to a stone 71.41 on old line,  
thence along said line 71.72 N. 20.10 to stone  
(Hickory poles) thence 73.4 N. 68.4 W. 13.90 to stone  
by fence, thence 71.34 N. 11.45 to a stone on  
side of Tugaloo Road thence running east  
with said road S. 6 E. to stone 71.84 1/4 E. 20.25 to
