at the rate of *Seven* per centum per annum until paid; interest to be computed and paid *semi-* annually, and if unpaid when due to bear interest at same rate as principal until paid, and I *Mrs. Mary L. Pack* have further promised and agreed to pay ten per cent. of the whole amount due for attorney's fees, if said note be collected by an attorney or through legal proceedings of any kind, reference being hereunto had will more fully appear.

in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof according to the terms of the said note and also in consideration of the further sum of Three Dollars to me

in hand well and truly paid at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said *Mrs. Mary L. Pack, her heirs and assigns*

all that piece, parcel, tract or lot of land situated in *Butler*

Township *Butler* County, State of South Carolina, described as follows: Beginning at a stone 3X at corner of lands of Toms, Miller and Sullivan and runs thence S. 69.41 W. 2327 feet to stone; thence N. 20.02 W. 1344 feet to an iron pin, corner of Conyers and Miller; thence S. 69.50 W. 1516 feet to an iron pin; thence S. 46.40 W. 1791 feet to a stone; thence S. 61.45 W. 757 feet to a stone across the branch; thence S. 34.10 E. crossing the branch 2240 feet to a stake; thence S. 53.45 W. 1129 feet to a corner, double hickory; thence S. 31.05 E. 2700 feet to a pile of rock, corner; thence N. 33.10 E. 7747 feet to the beginning corner, containing four hundred twenty-four acres (424), more or less, and being the same land conveyed to me by Mrs. Mary L.
