the line of lot No. 87 N. 89-1/2 W. 150 feet to a stake on an alley; thence with said
alley S. 0-30 W. 153 feet to a stake on new cut road; thence with the new cut road S.
84 E. 150 feet to the beginning corner and being designated as lots Nos. 88, 89 and 90
in Block C., as shown on plat recorded in Plat Book A., page 460 and being the same lots
