side of Houston Street having the following meters and
bounds: Beginning on the West side of Houston Street
at a point 70.1 feet from the Northwest corner of Lucile
Avenue and Houston Street, and running thence with
Houston Street N. 2 E. 60.1 feet to an iron pin, corner
