until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or
interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue
thereon and foreclose this mortgage, said note further providing for an attorney's fee of 10% besides all costs and expenses of collection, to be added to
the amount due on said note to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof,
be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note, reference being
thereunto had, as will more fully appear.

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant,
bargain, sell and release unto the said Jas. M. Richardson, All that certain piece, parcel and lot of
land being and lying in the County and State aforesaid and on the north side of Babb St.,
in the Town of Fountain Inn, S.C. with the following metes and bounds to-wit: Beginning
at an iron pin on sidewalk at corner of J.L. Pressley and running with said sidewalk 85
feet to an iron pin; thence on parallel line with J.L. Pressley lot to C. & W.C. Railroad
thence with and along railroad line 85 feet to J.L. Pressley corner; thence along
J.L. Pressley line to the beginning corner and being a portion of land conveyed to me by
deed of Homer Garrett this 5th, day of January 1921 and known as portion of Fletcher
Thomason Lot.
