Todd, her heirs and assigns, from and against myself, my heirs, executors, administrators and assigns, and every person whomsoever lawfully claiming or to claim the same or any part thereof.

AND the said mortgagor agree S. to insure the house and buildings on said lot in the sum of not less than twenty five hundred Dollars, and keep the same insured from loss or damage by fire, and assign the policy of insurance to the said Annice W. Todd and that in the event the mortgagor shall at any time fail to do so, then the said mortgagee may cause the same to be insured in her name, and reimburse herself for the premium and expense of such insurance under this mortgage.
