

TOGETHER with all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in any-wise incident or appertaining.

TO HAVE AND TO HOLD, All and singular the said premises unto the said The First National Bank of Greer, S.C., its successors, heirs, and assigns, forever. And I do hereby bind myself and my heirs, executors and administrators to warrant and forever defend all and singular the said premises unto the said The First National Bank of Greer, its successors, heirs, executors, administrators and assigns, and every person whomsoever lawfully claiming or to claim the same or any part thereof.

AND IT IS AGREED, By and between the said parties, that mortgagor is to hold and enjoy the said premises until default of payment shall be made.
