AND the said *Tryon Development Company* agree to insure the house and buildings on said lot in the sum of not less than *Twelve hundred* Dollars, and keep the same insured from loss or damage by fire and assign the policy of insurance to the said *Bank of Tryon* and that in the event the mortgagor shall at any time fail to do so, then the said *Bank of Tryon* may cause the same to be insured in *its* name, and reimburse *itself* for the premium and expense of such insurance under this mortgage.

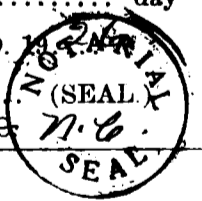
