in the first Ward of the City of Greenville, having the following
metes and bounds, to wit: Beginning at a stake
on the south side of West Stone Avenue in the corner
of land conveyed by said W. K. Hale to Mrs. Delia
Mary White and thence along said Avenue
N. 84 1/2 W. Sixty-six (66) feet to a stake; thence S. 4 1/2 W. one
hundred and sixty-two (62) feet to a stake; thence
S. 84 1/2 E. Sixty-six (66) feet to a stake on the south-west
corner of Mrs. White's lot; thence along a line of said
