WHEREAS, I, the mortgagor hereinabove named

in and by my certain 1919 note in writing, of even date with these presents. are well and truly indebted to Houey Smith the mortgagee hereinafter named.

Seven Thousand Four Hundred Dollars (\$7400.00) in the full and just sum of DOLLARS, to be paid 22 monthly installments of Sixty-five (\$65.00) each, on the lunthfifth day of each month thereafter, beginning on the twentthfifth day of January, 1920 until paid in full.

with interest thereon from this date at the rate of 6 1/2 per cent. per annum, to be computed and paid quarterly until paid in full; all interest not paid when due to bear interest at same rate as principal; and if any portion of principal or interest be at any time past due unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; said note further providing for an attorney's fee of one percent of the undischarged balance.

besides all costs and expenses of collection, to be added to the amount due on said note to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney, or by legal proceedings of any kind or if any part of the money due on said note be not paid when due (of which is secured under this mortgage), as in and by the said note, reference being thereunto had, will more fully appear.

Houey Smith and his heirs and assigns, all that certain lot of land in Greenville Township, Greenville County, South Carolina, in the city of Greenville known as lot 21 and subject of the same Deed recorded in the Clerk Book "Z" page 10, in the office of the Register of Deeds Conveyances for said County, and W. A. Adams as Surveyor of same having been made up W. A. Adams; May 1919. Said lot has the following corners and boundaries, to-wit: Beginning at the south side of Forest Street, joint corner of lot 20 and 21; said running thence 84 1/3° W. one hundred and Eighty (180) feet; thence 41 1/4° W. 11 1/4° E. 180 feet to Forest Street; thence with Forest Street 48 1/2° E. 70 feet to the beginning corner, this being the same lot this day surveyed to me, the said Dickey France, by the said Houey Smith; this being a first mortgage upon said property given to secure the payment of the balance of the purchase money thereof.
