lying and being in the County of Greenville and State aforesaid, in the Town of Greer on Mostellar Street (formerly Broad Street) and having the following metes and bounds, to-wit: Beginning at a point on said Mostellar Street (Formerly Broad Street) and running thence with said Street S. 7.27 W. 61.9 feet; thence S. 82.35 E. 175 feet; thence N. 7.25 E. 61.9 feet; thence N. 82.35 W. 175 feet to the beginning corner, being lot No. 3, of Block 2, on plat recorded in R.M.C. Office for Greenville County in Book A., page 299. One-half (1/2) of a ten (10) foot driveway is expressly reserved hereby on the line of the above lot which is adjacent to lot No. 2.
