Greenville Township, Greenville County, State of South Carolina, in the City of Greenville
on the southeast side of Pettigru Street, and described as follows: Beginning at a stake
on Pettigru St. 61-1/2 ft. from the southeast corner of Pettigru and Whitsett Streets, at
corner of lot No. 137, and running thence with Pettigru St. in a southwestern direction 60
feet to corner of lot No. 139; thence with line of that lot in a southeastern direction 152
feet to a stake; thence in a northerly direction 90 feet to corner of lot No. 137; thence
with line of that lot in a northwestern direction 126 feet to the beginning corner, and
