Dollars, to be paid on or before 8th. April 1924

with interest thereon from April 8, 1921 at the rate of Eight per cent. per annum to be
computed and paid annually

until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or
interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue
thereon and foreclose this mortgage, said note further providing for an attorney's fee of ten per centum
besides all costs and expenses of collection, to be added to
the amount due on said note, to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof,
be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note, reference being
thereunto had, as will more fully appear.

in consideration of the said debt and sum of money paid, and for the better securing the payment thereof to the said

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant,
bargain, sell and release unto the said Wade Floyd

being in Greenville County Pario Mountain Township and
State aforesaid adjoining lands of Raiford Gillson, E. E.
Jones, O. M. Hadden Mary J. McNabb and others, same
being more fully described by a plat drawn by R. E. Dalton,
Engineer, October 1914, containing six and 68/100 acres.

Also all that piece, parcel or tract of land situated
lying and being in Greenville County, Pario Mountain Township
and State aforesaid and adjoining the land of William
Priestly, Arthur Mc Junken William Fleming, James Thompson
containing ten acres more fully described by a plat
