Situate lying and being in the city of Greenville on the East side of West Washington Street, being known and designated as Lot No. 9, and having the following metes and bounds, according to a plat made by C. M. Furman Jr., dated April 15, 1920, and recorded in Plat Book "E" Page 240, R. M. C. Office for Greenville County.
