I, Maggie Johnson of Greenville, State and County  
aforsaid SEND GREETING:

WHEREAS, I, the said Maggie Johnson

in and by my American certain promissory note in writing of even date with these presents  
well and truly indebted to GREENVILLE BUILDING AND LOAN ASSOCIATION, a corporation, incorporated under the law of the State of South Carolina, in  
the full and just sum of Two thousand two hundred fifty + 00/100  
(2,250.00) DOLLARS,

to be paid on or before the date when the 6th Series of the Capital Stock of the said American  
BUILDING AND LOAN ASSOCIATION shall reach maturity, with interest thereon from date at the rate of eight per cent per annum, payable weekly on or before  
Saturday night of each and every week until paid in full; and if I and 26th Nov fail to pay said interest or  
to comply in all respects with the Constitution and By-Laws of said Association, for the space of thirty days, then said debt shall become immediately due and payable,  
together with all interest, fines and expenses, and all amounts advanced by the said Association on the within described property, by way of taxes or insurance, the  
same to be added to the amount due on said note and to be collectible as part thereof, together with an attorney's fee of ten per cent. if the same be placed in the hands  
of an attorney for collection, or if said debt, or any part thereof be collected by an attorney, or legal proceedings of any kind (all of which is secured under this  
mortgage); as in and by the said note, reference being hereunto had, will more fully appear.

ASSOCIATION, according to the terms of the said note, and also in consideration of the further sum of Three Dollars, to me

in hand well and truly paid by the said GREENVILLE BUILDING AND LOAN ASSOCIATION at and before the signing of these presents, the receipt whereof is  
hereby acknowledged, have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said American BUILDING  
AND LOAN ASSOCIATION

All that certain piece, part of lot 47 of land, situate  
lying and being in Greenville Township, State and County  
aforesaid on the North side of Lincoln Street just  
outside the city of Greenville, and known as lot  
no. 47 of "Washington Heights" subdivision according to a  
plat made by C. M. Furman, Jr. February 3, 1922 and  
recorded in the R. M. C. Office, for Greenville County  
in Plat Book "P" at page 54. Said lot having the  
following dimensions: fronting 47.5 feet on Lincoln  
Street; width 53.2 feet at the rear; depth 80 feet  
on the eastern side and 80.2 feet on the western  
side.
