SEND GREETING:

WHEREAS, I, the said A. D. Thomas

in and by my certain promissory note in writing of even date with these presents was  
well and truly indebted to GREENVILLE BUILDING AND LOAN ASSOCIATION, a corporation, incorporated under the laws of the State of South Carolina, in  
the full and just sum of Five hundred (\$500.00)

Five DOLLARS,

to be paid on or before the 25th Series of the Capital Stock of the said GREENVILLE  
BUILDING AND LOAN ASSOCIATION shall reach maturity, with interest thereon from date at the rate of eight per cent. per annum, payable weekly on or before  
Saturday night of each and every week until paid in full; and if I fail to pay said interest or  
to comply with all respects with the Constitution and By-Laws of said Association, for the space of thirty days, then said debt shall become immediately due and payable,  
together with all interest, fines and expenses, and all amounts advanced by the said Association on the within described property, by way of taxes or insurance, the  
same to be added to the amount due on said note and to be collectible as part thereof, together with an attorney's fee of ten per cent. if the same be placed in the hands  
of an attorney for collection, or if said debt, or any part thereof be collected by an attorney, or legal proceedings of any kind (all of which is secured under this  
mortgage); as in and by the said note, reference being hereunto had, will more fully appear.

NOW, KNOW ALL MEN, That I, the said A. D. Thomas

in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said GREENVILLE BUILDING AND LOAN  
ASSOCIATION, according to the terms of the said note, and also in consideration of the further sum of Three Dollars, to me  
the said A. D. Thomas

in hand well and truly paid by the said GREENVILLE BUILDING AND LOAN ASSOCIATION at and before the signing of these presents, the receipt whereof is  
hereby acknowledged, have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said GREENVILLE BUILDING  
AND LOAN ASSOCIATION. All that certain piece, parcel or lot of land situate, lying and  
being in the County of Greenville, State aforesaid, near the City of Greenville, being lot  
No. 20 of the subdivision known as Morgan Hill, plat of which is recorded in office of  
R.M.C. for Greenville County, having the following metes and bounds: Beginning at an iron  
pin on O'Neall Street and running thence S. 7-1/4 E. 200 feet to an iron pin; thence S.  
82-3/4 W. 60 feet to an iron pin; thence N. 7-1/4 W. 200 feet to an iron pin in O'Neall Street,  
thence with O'Neall Street N. 82-3/4 E. 60 feet to the beginning corner, being the same  
lot of land conveyed to me by Sallie D. Olson by deed dated August 29th, 1918 and recorded  
in Vol. 20, page 283, R.M.C. office for Greenville County. This being a second mortgage over  
the above described lot, being second to a mortgage to the Greenville Building & Loan
