the full and just sum of twenty-three hundred & no/100 (\$2300.00)

DOLLARS,

to be paid on or before the date when the 31st Series of the Capital Stock of the said GREENVILLE
BUILDING AND LOAN ASSOCIATION shall reach maturity, with interest thereon from date at the rate of eight per cent. per annum, payable weekly on or before
Saturday night of each and every week until paid in full; and if fail to pay said interest or
