WHEREAS, I, the said Robert I. Allen

in and by my certain promissory note in writing of even date with these presents are
well and truly indebted to GREENVILLE BUILDING AND LOAN ASSOCIATION, a corporation, incorporated under the laws of the State of South Carolina, in
the full and just sum of Three Thousand (\$3000.00)

DOLLARS,
