in and by me certain promissory note in writing of even date with these presents am  
well and truly indebted to GREENVILLE BUILDING AND LOAN ASSOCIATION, a corporation, incorporated under the laws of the State of South Carolina, in  
the full and just sum of One Thousand 20/100

DOLLARS,

to be paid on or before the date when the 32nd Series of the Capital Stock of the said GREENVILLE  
BUILDING AND LOAN ASSOCIATION shall reach maturity, with interest thereon from date at the rate of eight per cent. per annum, payable weekly on or before  
Saturday night of each and every week until paid in full; and if fail to pay said interest or  
to comply in all respects with the Constitution and By-Laws of said Association, for the space of thirty days, when said debt shall become immediately due and payable,

described as follows: Beginning at an iron pin on Tindal Avenue, corner of Lot No. 38, and  
running thence S. 8-21 E. 151.2 feet to iron pin; thence S. 89.07 W. 50 feet to an iron  
pipe, corner of Lot No. 40; thence with line of Lot No. 40 N. 12-31 W. 152 feet to an iron
