the full and just sum of Thirty-five Hundred (\$3500.00)

DOLLARS,

to be paid on or before the date when the 32 Series of the Capital Stock of the said GREENVILLE
BUILDING AND LOAN ASSOCIATION shall reach maturity, with interest thereon from date at the rate of eight per cent. per annum, payable weekly on or before

Saturday night of each and every week until paid in full; and if I fail to pay said interest or
to comply in all respects with the Constitution and By-Laws of said Association, for the space of thirty days, then said debt shall become immediately due and payable,
together with all interest, fines and expenses, and all amounts advanced by the said Association on the within described property, by way of taxes or insurance, the

AND LOAN ASSOCIATION All that certain piece, parcel or lot of land in Greenville Township,

Greenville County, State of South Carolina, in the City of Greenville, on the South
side of West Earle Street, between Robinson and Wilton Streets: Beginning at an iron pin
two hundred and seventeen feet and four inches from the East side of Robinson Street,
and running thence with Earle Street S. 83-13 E. fifty-four feet and four inches to an
iron pin; thence S. 6-47 W. two hundred feet to an iron pin; thence N. 83-13 W. fifty
four feet and four inches to an iron pin; thence N. 6-47 E. two hundred feet to the
