And the said mortgagor agree to insure the house and buildings on said lot in the sum of not less than three thousand Dollars, and keep the same insured from loss or damage by fire, and assign the policy of insurance to the said G. W. Bidwell

and that in the event the mortgagor shall at any time fail to do so, then the said mortgagee may cause the same to be insured in his name, and reimburse himself for the premiums and expense of such insurance under this mortgage.

AND IT IS AGREED, by and between the said parties, that I am to hold and enjoy the said Premises until default of payment shall be made.

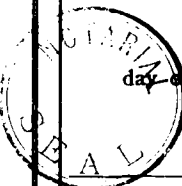
