All that piece, parcel or lot of land situate lying and being in state and county aforesaid in Cleeland Township north side Middle Saluda River and having the following metes and bounds to-wit: Beginning on Holly on north side of branch + running n. 81 W. 3.45 to stake on branch; thence south with said branch 3.27 to mouth of said branch where it empties into middle Saluda River thence down said river 2.60 to mouth of branch; thence up + with said branch to Holly the beginning, containing one acre more or less being same conveyed to me by C. E. Slaten by deed dated September 10th 1919 + recorded in Vol. 70 page 180. Also all that piece parcel or lot of land in the state, county + township aforesaid starting at mouth of branch running n. 87 W. up middle Saluda River 1.49 to a beech thence n. 7 E. 3.41 to a stake on south bank of branch; thence along branch to the beginning point and containing four-tenths of an acre, more or less and being same conveyed to me by B.
