WHEREAS, I, the said F. C. Bright  
in and by a certain promissory note in writing, of

in the full and just sum of Three Thousand THE DEBT HEREBY SECURED IS PAID IN  
Dollars, to be paid in three equal annual installments of 1000<sup>00</sup> each FULL AND THE LIEN OF THIS INSTRUMENT  
beginning Oct. 27<sup>th</sup> 1921 and ending October 27<sup>th</sup> 1924 IS SATISFIED. THIS  
OF July 12 1921

with interest thereon from October 27<sup>th</sup> 1921 BY B. M. McJee at the rate of 8 per cent. per annum to be  
computed and paid annually WITNESS: B. M. McJee

until paid in full; all interest not paid when due to bear interest at the same rate as principal, and if any portion of principal or  
interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due at the option of the holder hereof, who  
may sue thereon and foreclose this mortgage, said note further providing for an attorney's fee of

Ten per cent besides all costs and expenses of collection, to be added to  
the amount due on said note, to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part  
thereof, be collected by an attorney or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note, reference  
being thereunto had, as will more fully appear.

NOW, KNOW ALL MEN, That I, the said F. C. Bright  
in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said

according to the terms of the said note, and also in consideration of the further sum of Three Dollars, to me the said  
F. C. Bright  
in hand well and truly paid by the said B. M. McJee

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do  
grant, bargain, sell and release unto the said B. M. McJee his heirs & assigns

all that piece, parcel or lot of land situate lying and being  
in Greenville County State of South Carolina and containing  
Five Hundred & Sixty One (561) acres more or less, and being the  
same lands conveyed to me by Eliza M. Miles 2nd December 1912  
and more fully described in said Deed recorded in Book 21  
page 499. B. M. C. Greenville County South Carolina, reference  
to said Deed is hereby craved for more particular description  
of said land.
