

THE STATE OF SOUTH CAROLINA,

TO ALL WHOM THESE PRESENTS MAY CONCERN:

I, Mary L. Wilkinson, of Greenville, in the County of Greenville and State of South Carolina, SEND GREETING:

WHEREAS, I the said Mary L. Wilkinson in and by my certain bond or obligation, bearing date the 18th day of October 1922, stand firmly held and bound unto THE CAROLINA LOAN AND TRUST COMPANY, of the City and County of Greenville, in said State (a body corporate, duly incorporated under the laws of such State), in the penal sum of Ten Thousand & No/100 (\$10,000.00) Dollars,

conditioned for the payment of the full and just sum of Five Thousand & No/100 (\$5,000.00) Dollars, with interest thereon at the rate of eight per centum per annum, payable monthly, from the 18th day of October A. D. 1922 according to the provisions of the Charter, By-Laws, Rules and Regulations of said Company, in manner and form the following, that is to say,

that I the said Mary L. Wilkinson shall pay, or cause to be paid, to the said Company, or its certain attorneys, successors, or assigns, at Greenville City aforesaid, monthly, on the 20th day, or before the end of the month of October 1922, and on the 20th, or before the end of each month thereafter, for twenty successive months, the sum Eighty - Three & 33/100 (\$83.33) Dollars (\$50.00) Dollars,

being the regular monthly installment payable on the Fifty shares of stock, and Thirty - Three & 33/100 (\$33.33) Dollars being the monthly interest on the advance (or loan), until there have been paid twenty monthly payments, and shall for the next twenty months pay the sum of Seventy - Six & 67/100 (\$76.67) Dollars (\$50.00) Dollars,

being the regular monthly payment on said stock and Twenty - Six & 67/100 (\$26.67) Dollars being the monthly interest on balance due; for the next twenty months the sum of Seventy & No/100 (\$70.00) Dollars (\$50.00) Dollars being the regular monthly payment on said stock and Twenty & No/100 (\$20.00) Dollars being the monthly interest on balance due); for the next twenty months pay the sum of Sixty - Three & 33/100 (\$63.33) Dollars (\$50.00) Dollars,

being the monthly payment on said shares of stock and Thirteen & 33/100 (\$13.33) Dollars being the monthly interest on balance due); for the next twenty months pay the sum of Fifty - Six & 67/100 (\$56.67) Dollars (\$50.00) Dollars being the monthly payment on said shares of stock and Six & 67/100 (\$6.67) Dollars, being the monthly interest on balance due).

Each of the above payments to be made on the 20th, or before the last day, of each month, and shall thereafter surrender to the Company the said 50 shares of stock and the certificate thereon, the amount at such time paid on the said shares by me to be credited as a payment upon the advance or loan made me, the said Mary L. Wilkinson and shall pay or cause to be paid, all fines which may be duly imposed upon, or charged against me, the said Mary L. Wilkinson in accordance with the Charter, By-Laws, Rules and Regulations, as in and by the said bond or obligation, and the condition thereunder written, reference being thereunto had will more fully appear.

NOW, KNOW ALL MEN, That I, the said Mary L. Wilkinson in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said THE CAROLINA LOAN AND TRUST COMPANY, according to the condition of the said bond or obligation, and also in consideration of the further sum of FIVE DOLLARS, to me the said Mary L. Wilkinson in hand well and truly paid by the said THE CAROLINA LOAN AND TRUST COMPANY, at and before the sealing and delivery of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and, by these Presents, do grant, bargain, sell and release unto the said THE CAROLINA LOAN AND TRUST COMPANY, all that tract or parcel of land situated in the County of Greenville State of South Carolina, and described as follows:

On groue road and having the following meters and bounds according to a plat made by R. E. Dalton.

Beginning at an iron pipe on the north side of Groue Road, corner of lot no. 14 Block "M" of property of O. P. Mills; thence along line of Lot No. 14, N. 48-22 W. 180.4 feet to an iron pipe on rear line; thence along rear line S. 45-27 W. 62 feet to an iron pipe corner of Lot 16; thence along line of Lot 16, S. 48-22 E. 180.7 feet to an iron pipe on the north side of Groue Road; thence around a curve in Groue road to a stake at point of curvature, the course and distance of chord being N. 44-23 E. 18 feet; thence continuing with Groue Road N. 47-27 E. 44 feet to the point of beginning, being known and designated as lot No. 15 of Block "M" and being the same lot conveyed to me by Susan C. Mills by deed dated September 8th 1922, and recorded in volume 75 Page 372, R. M. C. office for Greenville county.
