eleven hundred and seventy-five Dollars, (\$ 1,175.00); all of said notes bearing even date herewith and bearing interest from this date at the rate of seven

per cent. per annum, to be computed and paid \_\_\_\_\_ annually until \_\_\_\_\_ in full, all interest not paid when due to bear interest at the rate of seven per cent. per annum; and being hereby agreed that each of said notes shall bear interest after maturity or after default in payment at the rate of seven per cent. per annum, to be computed \_\_\_\_\_ annually, all interest not paid when due to bear interest at the rate of seven per cent. per annum; and that both principal and interest shall be paid in United States gold coin of the present standards of weight and fineness; all the terms and covenants of said notes being hereby made parts hereof as fully as if set out at length herein.

Now, know all men that said mortgagor, in consideration of said debt and for the purpose of securing the payment thereof, and in further consideration of the sum of one dollar paid to said mortgagee at and before the sealing and delivery hereof (the receipt whereof is hereby acknowledged), has granted, bargained, sold and released and by these presents does grant, bargain, sell and release unto the said mortgagee and his heirs, successors and assigns all that certain lot, piece, parcel or tract of land situated, lying and being in the State of South Carolina and County of Greenville in Greenville Township, at or near the corporate limits of the City of

Greenville, known and designated as lot number thirty-one (31) on a plat of Mrs. H. D. - Wilkins' property made by R. E. Dalton, dated March, 1924, and recorded in the office of the Register of Mesne Conveyances for said County and State in Plat Book "F", at page 209, and having, according to said plat, the following metes and bounds, to-wit:- Beginning at an iron pipe on the west side of Ladson Street one hundred and twenty-six and seventy-two one-hundredths (126.72) feet northward from the north side of Otis Street, and running thence along Ladson Street N. 11° 57' W. sixty-three and thirty-six one-hundredths (63.36) feet to an iron pipe on the south-east corner of lot No. 30; thence along line of last mentioned lot S. 72° W. one hundred and fifty-seven and five-tenths (157.5) feet to an iron pipe on Hill Street; thence along Hill Street S. 2° 44' E. sixty-five and three-tenths (65.3) feet to an iron pipe on the north-west corner of lot No. 34; thence N. 72° E. one hundred and sixty-eight (168) feet along the line of lots thirty-four and thirty-two to the beginning corner; this being the same lot this day conveyed to me by said Title Guarantee and Trust Company, as Trustee.
