That lot of land situate in the county and State aforesaid, in the town of Greer, having the following metes and bounds.

Beginning at an iron pin on the west side of Line Street at a point 279 feet in a southerly direction from the intersection of Line Street with Arlington Avenue, at the corner of lot #5, and runs thence with the line of lot #5 in a westerly direction 115 feet to an iron pin on line of lot #6; thence with the line of lot #6 in a southwesterly direction 40 feet to an iron pin, joint corner of lots #6 and #7; thence S. 61-30 E. 137.4 feet to an iron pin on Line Street; thence with Line Street N. 89 degrees 00 minutes 00 seconds E. 90 feet to the beginning corner. This lot being designated as lot #7 on a plot of land called "Cannon Heights" H. B. Bailey survey 1928. Said plot recorded in the R. M. C. Office for said County in Vol. Plat Book C. at page 248, and is the same lot of land conveyed to me by L. M. Wood, in deed bearing date February 14th 1925.

Also, all that other lot of land situate in the county and State aforesaid, in the town of Greer, adjoining the next above described lot and having the following metes and bounds: Beginning at the corner of lots #6 and #7 as designated on said plot of "Cannon Heights" and runs thence S. 61-30 E. 137.4 feet to the corner of lot #7 on Line Street; thence S. 8-00 W. 10 feet more or less, along Line Street to the corner of Mrs. Elizabeth Westmoreland's property; thence along the line of her property to a point of intersection in said line made by a continuation of the line of division between lots #2, #3 and #6 on one side and #1, #4, #5 and #7, on the other as designated on said plot; thence along the line of said continuation 17 feet more or less to the beginning corner, being the same lot of land
