AND the said E. E. Sloan agree S to insure the house and buildings on said lot in the sum of not less than Eight Hundred Dollars Dollars, and keep the same insured from loss or damage by fire and assign the policy of insurance to the said R. D. Dobson and that in the event the mortgagor shall at any time fail to do so, then the said R. D.
