Brannon*.....according to the terms of the said *note* and also in consideration ofthe further sum of Three Dollars to *me* the said *F. J. Jones*in hand well and truly paid by the said *D. B. Brannon*at and before the sealing and delivery of these Presents, the receipt whereof is hereby acknowledged, have Granted, Bargained, Sold and Released, and by these Presents do Grant, Bargain, Sell and Release, unto the said *D. B. Brannon*:

All that piece, parcel, or lot of land, situate, lying and being in the County and State aforesaid, having the following metes and bounds:

Beginning at a point in the intersection of the National Highway and a new Road leading to Fair View Church and runs thence with the said New Road N. 8 N. 3.16 chs. to an iron pin at the corner of Lot #3; thence along the line of lot No. 3 N. 12 E 3.00 chs to the joint corner of lot #4 and #7; thence along the line of lot #7 S. 55³/₄ E. 5.88 chs. to an iron pin; thence S. 41¹/₂ N. 5.18 chs to a poplar; thence S. 48¹/₄ E 6.2 chs to a stump; thence S. 8³/₄ N. 5.17 chs to the Nat. Highway thence along the Nat. Highway S. 67³/₄ N. 1.26 chs to the beginning, containing one and twenty-eight one hundredths of an acre (1.28), more or less, and being designated as lot No. 6 on a plat of the D. B.
