I, *W. B. Jones*, of *Greenville, S.C.*

SEND GREETING:

WHEREAS, *I*, the said *W. B. Jones*

in and by *my* certain promissory note in writing, of even date with these presents *and* well and truly indebted to AMERICAN BUILDING AND LOAN ASSOCIATION, a corporation, incorporated under the laws of the State of South Carolina, in the full

and just sum of *Twenty Five Hundred (\$2500.00)* Dollars,

to be paid on or before the date when the *2nd* Series of the *Installment*

Stock of the said AMERICAN BUILDING AND LOAN ASSOCIATION shall reach maturity, with interest thereon from date at the rate of eight per cent. per annum, payable weekly on or before Saturday night of each and every week until paid in full; and if *I*

All that certain piece, parcel or lot of land situate on Arlington Avenue in the City of Greenville, and being more particularly described as follows: Beginning at the corner of Nannie Ellison's lot and running thence with the line of that lot N. 27 E. 114 feet and 5 inches to an iron pin; thence S. 71-3/4 E. 33 feet and 7 1/2 inches to a stake; thence N. 28-3/4 W. 116 feet to a stake on Arlington Avenue; thence with said Arlington Avenue N. 69 W. 30 feet to the beginning corner, and being the same lot of land this date conveyed to me by J.W. Kirkpatrick. It is understood between the parties hereto that this mortgage is a first lien upon the premises above described.
